

FY2024 Global Reporting Initiative ("GRI") Content Index

This GRI content index supports the FY2024 ESG disclosures for Macquarie Group Limited ("MGL" or "Macquarie") and its subsidiaries. Our ESG disclosures comprise relevant sections of Macquarie's FY2024 Annual Report and Macquarie's website. Macquarie has reported the information cited in this GRI content index for the period 1 April 2023 to 31 March 2024 with reference to the GRI Standards, based on the requirements outlined in *GRI 1: Foundation 2021*. There are no GRI Sector Standards applicable to Macquarie.

Macquarie is committed to aligning the reporting of our ESG impacts to reflect evolving user expectations, new reporting standards and frameworks, and regulations. In the context of this evolving landscape, Macquarie has transitioned our ESG reporting from "in accordance with the GRI Standards" to "with reference to the GRI Standards".

To support consistency, we have made reasonable efforts to continue to report on information which has been disclosed in the past, however it is believed that this new approach will allow Macquarie to better tailor content which we believe will meet the key information requirements of users, while allowing us to focus on readying ourselves for upcoming mandatory ESG reporting under a range of new frameworks and standards.

In relation to the disclosures against the GRI Topic Standards for each material topic, in some instances, certain disclosures for that topic have not been provided in full and these are marked as a 'Partial disclosure'. In addition, where the data to meet the disclosure requirements is unavailable or incomplete, these disclosures have been removed.

The content of the disclosures is based on Macquarie's ESG focus areas, which are reviewed annually and selected as most relevant to Macquarie based on internal and external research, engagement with stakeholders, market benchmarking, and topic prioritisation.
