# Macquarie Group Limited - Issuance of Macquarie Group Capital Notes 6

SYDNEY, Friday, 15 July 2022 - Macquarie Group Limited (ASX: MQG; ADR MQBKY) ("MGL") today announced that it has issued 7,500,000 Macquarie Group Capital Notes 6 ("MCN6") at an issue price of A\$100 each, raising A\$750 million.

MCN6 are expected to commence trading on the ASX on a normal settlement basis on Monday, 18 July 2022 under the ASX code "MQGPF".

### **Allocation Policy**

Allocations to Syndicate Brokers and Institutional Investors were determined under the Bookbuild completed on Thursday, 29 June 2022.

Allocations to individual Broker Firm Applicants by a Syndicate Broker were at the discretion of that Syndicate Broker.

### **Holding Statements**

CHESS and issuer sponsored Holding Statements indicating the number of MCN6 allocated to successful Applicants are expected to be dispatched by Thursday, 21 July 2022.

Broker Firm Applicants can confirm their holding before receiving their Holding Statement by contacting their Syndicate Broker.

Institutional Investors have already been advised of their allocations.

Any successful Applicant wishing to trade their MCN6 prior to receiving their Holding Statement is responsible for confirming their allocation to ensure they do not sell any MCN6 that they do not own. Any person who sells MCN6 before receiving their Holding Statement does so at their own risk.

### First Distribution Payment

Distributions on MCN6 are scheduled to be paid on 12 March, 12 June, 12 September and 12 December each year (or the next business day if not a business day), commencing on 12 September 2022. The record date for the first MCN6 distribution is 26 August 2022.
